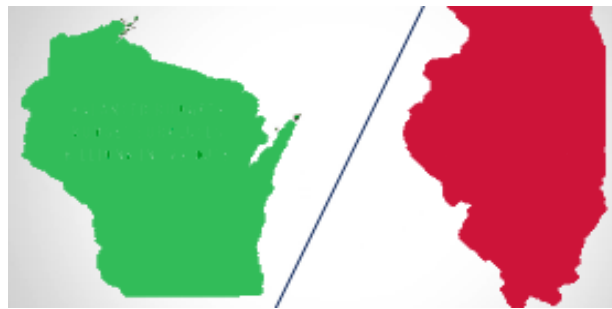


# WIS-ILL BI-STATE CHAMPIONSHIP HIGHPOWER RIFLE

## Official Tournament Program



**Date:** Saturday, June 18, 2022. Firing will begin at 9:00 A.M. Stat office will close at 8:30. Please arrive early for registration and squadding.

**Location:** Racine County Line Rifle Club  
8922 Rifle Range Rd, Racine WI.

**Rules:** Current NRA Highpower Rifle Rules will apply.

**Entries Close:** June 18, 2022, 8:30 A.M.

There will be no refunds for those canceling after firing starts.

**Fees:** \$35.00 per competitor, Juniors \$25.

Proceeds will go to Illinois and Wisconsin Junior rifle teams

**Eligibility:** Competition is open to all shooters. Any competitor being unsafe or disruptive may be told to leave the range.

**Entry Limit:** 60 competitors.

**Rifles Allowed:** Rifles falling under rules 3.1 (Service Rifles) or 3.3 (Match Rifles) will be allowed.

**Ammunition Allowed:** Any safe ammunition may be used.

**Empty Chamber Indicator (ECI):** Empty chamber indicators conforming to rule 3.21 are required to be used at all times except during the preparation period and firing.

**Scoring:** competitors will be responsible for scoring on their assigned firing point.

**Target Service:** Electronic targets will be used. Please bring a tablet device for scoring.

**Classification:** NRA Highpower classification will be used to issue awards.

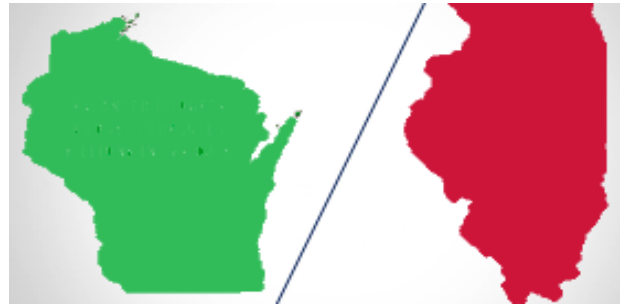
### **Course of fire:**

- **Match 1:** 2 sighting shots, 20 shots for record slow fire standing on the SR target from the 200-yard firing line. Time limit: 22 minutes.
- **Match 2:** 2 sighting shots, 2 ten shot strings rapid fire, sitting or kneeling, on the SR target from the 200-yard firing line. Time limit: 60 seconds for each record string.
- **Match 3:** 2 sighting shots, 2 ten shot strings rapid fire, prone, on the SR-3 target from the 300-yard firing line. Time limit: 70 seconds for each record string.
- **Match 4:** 2 sighting shots, 20 shots for record slow fire prone on the MR-1 target from the 600-yard firing line. Time limit: 22 minutes.
- **Match 5:** Aggregate of matches 1,2,3, and 4

**Awards:** The high score in each class and match winners will be awarded after the match is complete.

**Tournament Results:** A match bulletin will NOT be mailed. Final results will be posted approximately 30 minutes after firing has completed for the day. Printed match results may be picked up from the stat office at that time or viewed at <http://www.illinoishighpower.org>. Those competitors not wishing to have their names on the web site MUST notify the stat office by the conclusion of the tournament.

# WIS-ILL BI-STATE HIGHPOWER RIFLE CHAMPIONSHIP 2 MAN TEAM MATCH



**Date:** Saturday, June 18, 2022. Firing will begin shortly after the morning match.

**Location:** Racine County Line Rifle Club  
8922 Rifle Range Rd, Racine WI.

**Rules:** Current NRA Highpower Rifle Rules will apply.

**Entries:** entries and firing point assignment will be done on the firing line.

**Fees:** \$10.00 per competitor.

Fees will go to Illinois and Wisconsin Junior rifle teams

**Eligibility:** Competition is open to all shooters. Any competitor being unsafe or disruptive may be told to leave the range. Teams must have a shooter from Wisconsin and Illinois to be eligible for awards.

**Entry Limit:** 30 teams

**Rifles Allowed:** Rifles falling under rules 3.1 (Service Rifles) or 3.3 (Match Rifles) will be allowed.

**Ammunition Allowed:** Any safe ammunition may be used.

**Empty Chamber Indicator (ECI):** Empty chamber indicators conforming to rule 3.21 are required to be used at all times except during the preparation period and firing.

**Scoring:** competitors will be responsible for scoring on their assigned firing point.

**Squading:** Team squading will be determined by the competitors, match directors will assist at sign-in for individual shooters who need to find a team.

**Target Service:** Electronic targets will be used. Please bring a tablet device for scoring.

## **Course of fire:**

- **Stage 1:** 10 shots for record slow fire prone per shooter, on the MR-63 target from the 600-yard firing line. Time limit: 20 minutes
- **Stage 2:** 1 ten shot strings rapid fire, prone, on the SR-3 target from the 300-yard firing line. Time limit: 70 seconds for each record string.
- **Stage 3:** 1 ten shot strings rapid fire, sitting or kneeling, on the SR target from the 200-yard firing line. Time limit: 60 seconds for each record string.

**Awards:** match winners will be awarded after the match is complete. Team must have a shooter from Illinois and Wisconsin to be eligible for awards. All two persons teams are welcome to compete.

**Tournament Results:** A match bulletin will NOT be mailed. Final results will be posted approximately 30 minutes after firing has completed for the day. Printed match results may be picked up from the stat office at that time or viewed at <http://www.illinoishighpower.org>. Those competitors not wishing to have their names on the web site MUST notify the stat office by the conclusion of the tournament.
